General Information

Llyn Brenig Reservoir is recognised as one of the best top-of-the water trout fisheries in the UK. With 14miles (23km) of shoreline, it is one of the best places to go fishing in Conwy (possibly North Wales!) and is chosen for many international matches.

Fish are reared on site in the cold Llyn Brenig waters, enabling them to become fully acclimatised and earn their reputation as fierce fighters.

To accompany great fishing, there is a Lakeside Café and specialist Fishing Shop. If you are new to fly fishing, you can also book a flyfishing taster session at the Visitor Centre.

Known Species

Llyn Brening is stocked with 1000 fish each week. Mostly Rainbow Trout but Brown Trout are also stocked. Each year a Floy tag competition is held, with 300 tagged fish introduced over the course of the season. If you catch a tagged fish, you can enter the prize draw, first prize is £1000. Full details are available from the Visitor Centre.

Special Conditions

PAAS membership includes a limited number of bank fishing permits for Trout only on Tuesday Thursday Saturday and Sunday. Each member may visit 6 times per season and visits must be booked at least 7 days in advance. After booking, PAAS members must sign in at the Visitor Centre before fishing. Your PAAS membership card will be required. If you cannot make your booked visit, you must cancel your booking with the lodge in advance. Failure to do so will block your ability to book for 3 months.

All members must sign in to the PAAS diary before fishing commences.

Fishing is only by artificial fly, or dapped natural insect.

Excluding Brown Trout, which must be returned, 6 Fish over 12" (Measured from tip of the nose to the fork of the tail) may be retained. During the winter period (1st of November - February 28th) only 3 fish can be retained. When this limit has been reached, anglers may only continue to catch and release a further 12 fish and must use barbless hooks. No treble double or tandem hooks may be used at all.

Wading deeper than the thigh is prohibited. Anglers wade at their own risk.

Anglers must submit an accurate record of their catch after each visit and before leaving, including nil returns. Boxes for posting catch returns are provided at exits and on the jetty.

No fishing is permitted adjacent to dam, around the fish farm or the nature reserve (all marked off with yellow buoys). Fishing from any jetty is also prohibited. The front of the visitor center is prohibited for bank fishing. Other temporary restricted zones may be implemented for time to time. Bank anglers may not commence fishing in the line of a boat already fishing a drift.

Toilets are available on site.

Access and Parking

From the A55 North Wales Express Way leave at Junction 27a toward St. Asaph. Continue through Denbigh. At Lentern Pool roundabout, (Hand Inn), take the 2nd exit toward Pentrefoelas A543 for just over 8 miles. At Llyn Bran turn left onto B4501. After 3.7 miles the entrance to the Visitor Centre will be on your left. Follow the access road to the car park.

Note: Car Parking charges apply. To avoid being charged you must give your car registration number at the time of booking. Failure to do so could incur a fine or even having your car clamped.
